This Service Plan is available to customers who purchase 100% of their fuel and all heating system services from Wesco Oil during the term of the contract and whose payments are in accordance with our payment and credit terms. The plan becomes effective after our inspection and approval of your heating system. The plans are renewed annually if the customer cancels the plan for any reason before the end of the contract, they must do so in writing. No refunds will be made.

1. The term of this contract is for 1 year and will renew automatically unless terminated by Wesco Oil.
2. Upon inspection and acceptance of your system, Wesco Oil becomes obligated to repair or replace any part which in our opinion is defective through age or normal wear and which was on the system prior to the effective dates of the service contract.
3. Wesco Oil will not be liable for any parts or repairs that are the result of but not limited to: running out of oil, running low on oil, floods, freeze ups, acts of God, burner switch turned off, or any other cause beyond the control of Wesco Oil.
4. Both Gold & Platinum Plans include the cost of a cleaning (\$135.00 value). Additional costs may occur upon inspection of your heating system. These costs will be in addition to the contract.
5. All equipment covered under this plan must be inspected at the time of the cleaning/tune up to insure that the equipment has been sufficiently maintained by the customer. The burner controls and safety devices will be checked for proper operation and performance.
6. Customers agree to release Wesco Oil Co. from all claims of losses, costs, or damage to personal or real property caused by fire, explosion, flood, freezing, power loss or surges, oil leaks, and premises left unattended. Customer agrees that Wesco Oil shall not be liable for any incidental, special or consequential damages incurred by the customer or by third parties.
